

## Notes:

- 1. List provides current checks performed by the Research.gov system as of November 23, 2020, for proposals submitted in Research.gov.
- 2. The system currently only supports Research, RAPID, EAGER, and RAISE proposals that are: (1) single submissions from one organization; (2) single submission collaborative proposals with subawards; or (3) separately submitted collaborative proposals from multiple organizations. Not all program solicitations can be checked due to system constraints.
- 3. Some checks are not enforced for separately submitted collaborative non-lead proposals as stated by NSF policy requirements. The following sections are not required for a non-lead collaborative proposal: Project Summary, Project Description, References Cited, Postdoctoral Mentoring Plan, and Data Management Plan.
- 4. The system will be updated in the future to add support for other types of proposals and types of submissions.
- 5. Not all NSF policy requirements are currently enforced by automated compliance checks.
- 6. Current and Pending Support document checks apply to both proposals and to documents submitted with Research Performance Progress Report (RPPR) submissions when active other support has changed.
- 7. Compliance checks are triggered by "Allow SPO/AOR access" and "Submit" to NSF functions. There are additional actions while preparing a proposal that will trigger a compliance check (e.g., uploading documents).
- 8. Error Checks triggering an error will result in a hard stop and prohibit proposal submission to NSF.
- 9. Warning Checks triggering a warning will allow proposal submission to NSF.
