POSITION VACANT: Computer Specialist, GS-334-13. Salary ranges from \$60,890 to \$79,155 per annum.

PROMOTION POTENTIAL: Computer Specialist, GS-334-13

LOCATION: Directorate for Biological Sciences, Office of Information and Automation Resources Unit, Arlington, VA.

BARGAINING UNIT STATUS: This position is included in the Bargaining Unit and will be filled in accordance with the merit staffing provisions of the Collective Bargaining Agreement, Article VII.

AREA OF CONSIDERATION: All Sources. This position is open to status and non-status candidates, as well as candidates eligible for appointment under special non-competitive appointing authorities.

DUTIES AND RESPONSIBILITIES: At the performance level, the incumbent:

- Plans and directs BIO's computer support program within the framework of legislation, agency policies, missions, objectives, and resources.
- Provides oversight and management of the Directorate's computer systems. Serves as a team leader for Directorate-wide systems development projects. Coordinates the efforts of Division analysts and contractor personnel, when applicable.
- Serves as Directorate representative to the Division of Information Systems (DIS) with responsibility for speaking for the Directorate on all information systems matters. Advises DIS of Directorate problems, gives feedback on proposed DIS plans and initiatives, helps DIS test and evaluate new technologies, and advises DIS of Directorate needs for training and systems support.
- Serves as BIO's representative on permanent or ad hoc committees to evaluate applications of computer technology to the Directorate's research programs and to plan future approaches.
- Conducts continuing review of new developments in information technology and prepares long range forecasts concerning the potential value of these developments to the Directorate. Evaluates and selects hardware and software. Keeps abreast of industry trends by reading technical literature and periodicals and relevant training.
- Studies specific issues, programs or organizational units within the Directorate to identify current and potential problems or opportunities for productivity increases. Leads programming/systems analysis projects to resolve significant problems requiring resourcefulness and innovative solutions in many aspects of the project.

QUALIFICATIONS REQUIRED: **U.S. Citizenship is required.** The Qualifications Standards Handbook for General Schedule Positions will apply. Applicants must have one year of specialized experience equivalent to the next lower grade level. **Specialized Experience:** is experience that has equipped the applicant with the particular knowledge, skills, and abilities to successfully perform the duties of the position. **Time-in-Grade Requirement:** Completion of one year of service in a position no more than one grade lower than the grade for which you are applying.

QUALITY RANKING FACTORS:

- Knowledge of systems analysis and design techniques.
- Ability to direct a team of individuals in the analysis and design of computer systems and/or the delivery of a cohesive computer support program.
- Knowledge of technical advances in networking tools and technology, telecommunications, document text and graphics standards and optical imaging technology.
- Ability to communicate effectively, both orally and in writing on matters of a programmatic, technical, and administrative nature.
- Ability to instruct and work effectively with individuals who have a variety of backgrounds and training.

BASIS FOR RATING: Final ranking is based on an evaluation of your experience, education and training as they relate to the knowledge and abilities specified in the Quality Ranking Factors. Current performance appraisal and awards may also be used in the evaluation process.

CONDITIONS OF EMPLOYMENT: Appointment to this position is contingent upon successful completion of the appropriate background investigation. Satisfactory completion of a one-year probationary period may also be required.

HOW TO APPLY: You may apply for this position with the *Optional Application for Federal Employment* (OF-612), the older *Application for Federal Employment* (SF-171), a resume, or other application format of your choice - so long as it contains the necessary information (summarized below). Applicants who are eligible for appointment under special non-competitive appointing authorities must clearly specify specific eligibility and provide proof with application. Otherwise, the application will be considered under competitive procedures.

Applicants applying for special selection priority under the Interagency Career Transition Assistance Program must submit proof of eligibility (i.e., RIF separation notice, *Notification of Personnel Action* (SF-50) stating you were separated by RIF, OR a letter from your agency documenting your special selection priority status); copy of your current performance appraisal; and documentation of promotion potential in the position from which separated. To be determined well qualified to receive special selection priority for this position, you must meet all qualification and eligibility requirements, all selective factors, and be rated at the above average level or higher in each quality-ranking factor.

Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after three years or more of continuous active service may apply. Veteran
