
### Most capable optical/infrared telescopes for U.S. community

- Gemini's twin 8-m diameter telescopes, located on Mauna Kea, Hawaii, and Cerro Pachón, Chile, represent the largest-aperture optical/IR facilities available to the general observing communities of the partner countries.
- Key capabilities:

 High-resolution imaging with world's first multiconjugate adaptive optics system and a sophisticated coronagraphic instrument for imaging exoplanets

Multiobject optical spectroscopy

- Infrared sensitivity
- Multiple instruments + agile queue scheduling that enable unique target-of-opportunity science (e.g., LSST)



### Gemini Observatory – an international partnership

- Partnership of U.S., Canada, Australia, Brazil, Argentina,
   Chile, with U.S. at ~65% share
- Gemini Board is policy, budget-setting entity for Observatory
- NSF is Executive Agency, oversees managing organization (required by NSF charter) on behalf of partnership
- Association of Universities for Research in Astronomy (AURA) is current managing organization for Gemini
- Total annual Gemini contributions: ~\$27M Operations & Maintenance + ~\$4M instrument development (U.S. share ~\$18M, ~\$2-3M)

## Management competition in progress

- Consistent with NSB policy, competition of Gemini management for calendar years 2017-2022\* is underway
  - Letters of intent have been received
  - Site visits for potential proposers have been carried out
  - Proposals due February 27
  - Review panel has been assembled
  - Review scheduled for April 2015
- Requires 1-yr extension of current award to AURA
  - One-year proposal and full set of reviews are in hand
- Will return May 5-6, 2015 with <u>action item</u> for 1-yr award extension of \$30.851M for CY 2016
