The funds are predominantly the company's own but also include funds from outside organizations, such as other companies, research institutions, universities and colleges, nonprofit organizations, and state governments. Excludes company-funded R&D not performed within the company (e.g., R&D performed by other organizations) and company-funded R&D not performed within the 50 U.S. states or DC (e.g., R&D not performed on U.S. soil by foreign subsidiaries or other foreign organizations).
